10.1.1 REPORT NO. COR 2022-007 2022 Proposed Operating Budget

The Director of Corporate Services / Treasurer outlined the report.

The Director of Public Works and Engineering advised that with respect to the I&I program (Inflow and Infiltration), it is possible to isolate certain areas for monitoring; however, noted that with more investigation work, more neighbourhood details levels can be explored. It was noted that without dedicated resources, it is more of a high-level monitoring, and they are building towards a greater monitoring program.

The Director of Corporate Services / Treasurer advised that the investment income noted is a conservative estimate of what can be expected and as capital spending on projects increases the general account balance will come down. He further noted it is hard to anticipate the dividend income from Kitchener Wilmot Hydro.

The Director / Curator of Castle Kilbride confirmed that staff are planning 6 concerts for the summer months this year.

The Director of Corporate Services / Treasurer advised that a summary report for training and development for staff can be produced and included as part of the 2022 Work Program, noting that a lot of the programs provided to staff come at no charge.

The Director of Information and Legislative Services / Municipal Clerk advised that when sidewalk complaints are received staff respond accordingly from an enforcement perspective. The Director of Public Works and Engineering noted that in terms of consistency across the Township, that if staff are directed to investigate potential sidewalk maintenance, it could include additional fleet and staffing levels.
