The Director of Parks, Facilities and Recreation outlined the report and introduced Mr. Desai, who provided an overview presentation, attached as Appendix A.

Mr. Desai responded to Council that maximizing the use of the site is the goal; however, from an arena standpoint building a stacked arena is expensive and as the Township gets to the design phase, looking at sustainable options can be explored then. The Director of Parks, Facilities and Recreation noted that the design and development of a green facility are possible depending on budget requirements and noted that the proposed site at the Wilmot Recreation Complex may allow for mechanical efficiencies through the design.

The Director of Corporate Services noted that the original build on the Wilmot Recreation Complex is built based on Leadership in Energy and Environmental Design (LEED) standards without the certification as a cost saving measure.

The Director of Parks, Facilities and Recreation clarified that the Parks Operations division requires workspace to allow for construction and utilizing the second floor of the Recreation Centre is not feasible, outdoor secure space alongside indoor space is needed.

Mr. Desai noted that should the soccer facilities need to be relocated, there are options to allow for that relocation.

Mr. Desai advised that conversations have taken place with the Public Works and Engineering Department and that there are both benefits and challenges to combining Parks Operations and Public Works, noting that further conversations can take place.

Mr. Desai noted that the buildings would be attached and it would be an addition to the existing footprint. He advised, at this time the designs are preliminary and the next steps in the process would be the detailed drawings which can then explore sustainable building options.

The Director of Parks, Facilities and Recreation noted that adding a question regarding the the Township's 30 by 50 commitments to the survey is premature at this time as the survey is specific to the location.

Mr. Desai advised that cost estimates at this time show that a pre-COVID single pad arena would cost \$10-12 million; however, estimating costs at this time is difficult. He also noted that sharing the rinks with curling is challenging due to the different needs of the ice surface. The Director of Parks, Facilities and Recreation noted that Tavistock has a shared refrigeration system for a traditional ice pad and a curling pad and that could be an option if demand presents itself.

The Director of Parks, Facilities and Recreation noted that soccer may not be impacted by a potential fourth rink, but that parking requirements may be factor.

The Director of Parks, Facilities and Recreation advised that the survey questions are based on the recommendation in the report and the feedback from the community is the desired results from the survey to allow for a community voice to be heard.

Mr. Desai noted that with several organizations using one facility the design will require a review of traffic flow and parking requirements.

The Director of Parks, Facilities and Recreation advised that the consultant did discuss this report with all user groups prior to the release.

The Director of Information and Legislative Services outlined the report.

The Director of Information and Legislative Services clarified the process for approval of the By-law to include changes to applicant and delegation times, can be included through an amendment of the recommendation.

The CAO noted that time limits for delegations is a balance between allowing for voices to be heard and related to only matters on the agenda and a 5 minute timeline allows for that; noting that public engagement as a whole going forward includes increased opportunities for public engagement to be implemented and recommendations on those will be brought forward to Council.

The Director of Information and Legislative Services advised that delegations looking to request a different length of time to address Council should be speaking with staff initially as there could be potential financial implications or staff implications that should be tied to a staff report accompanying such community requests that allow for staff to work with delegations. The Director of Information and Legislative Services cautioned having a process in place to request a longer delegation time could impede the timeliness of the business of Council and it creates potential for every delegation to request extended time. The CAO advised that if there was a complex issue raised, staff would request a deferral and return with a staff report to Council.

The Director of Information and Legislative Services advised that if Council would like to adjust the applicant timeframe from 15 minutes to 10 minutes, that is within their authority to do so. She also advised against adjusting the delegation time limits based on the number of registered delegations due to deadline for registration.



# Study Background


In October 2020, Township Council approved the Indoor Arena Usage & Needs Analysis Update which recommended a third ice pad be provided in Wilmot in the short-term.

Council directed Staff and Monteith Brown Planning Consultants Ltd. to "undertake further study to determine strategies for delivering a third ice surface."

The Township's 10-Year Capital had separately identified the need to plan for a new Parks Operations Centre (currently housed at the WRC) due to recent and forecasted population growth in Wilmot.

Given the integrated nature of WRC arena and parks operations, the two studies were combined for process efficiencies.





## Study Purpose

- 1) **ARENAS:** To determine the optimal location for a third ice pad by either:
  - Expanding the Wilmot Recreation Complex;
  - Recommissioning the New Hamburg Community Centre; or
  - Selecting a new site if the existing arenas are deemed to not be suitable
- 2) PARKS OPERATIONS: Evaluate the continued suitability of the WRC for the Parks Operations Centre in light of current constratings, future growth needs and an ability to deliver efficient services





# The **Preliminary Findings Summary Report** includes:

- Summary of research, consultations and an analysis of the WRC and NHCC
- Outline of the operational needs of the Parks and Facilities Division
- Preferred options for a new arena and parks operations centre

We would like to receive direction from Township Council regarding the Preferred Options prior to initiating Phase 2

# Study Methodology

### Phase 1


- Engage arena users and Township staff
- Site tours of the WRC and NHCC
- Review background, trends, and best practices
- Develop site selection criteria
- Report Preliminary Findings to Council
- Test support with stakeholders and the public

### Phase 2

- Prepare conceptual plans and costing for the Preferred Sites
- Test support with stakeholders and the public
- Present Final Reports back to Council (early 2022)

# Input from Local Arena Stakeholders

- Users were supportive of the Township's decision to explore a third ice pad and indicated that the WRC was their preferred location
- NHCC was the secondary preference though some suggested it could become a practice rink or dryland training facility
- All groups support an NHL-regulation ice pad (200' x 85') with a minimum of 6 dressing rooms, seating typical of a community rink, and adequate storage
- The Community Players were engaged and articulated constraints at the NHCC such as lack of rehearsal space, storage and workshop
- Wilmot Soccer Club was also engaged given that expansion of the WRC building may have an impact on fields







# WRC: Existing Conditions

- Twin-pad arena built in 2007
- Co-located with indoor aquatics, youth centre, fitness space, sports fields, splash pad and playground
- Strong access to local and regional markets via Highway 7
- Adjacent land uses presently consist of Schmidt Woods and agricultural lands
- Building Condition Assessment finds the WRC in good condition
- Designed with modern barrier-free accessibility and building code standards in mind









# WRC: Opportunities & Constraints

## Opportunities

- Space exists to fit at least one additional ice pad (would require reconfiguration of parking lot)
- Strong geographic access and central location
- Retain economies of scale and efficiencies in arena operations
- Areas around the Nafziger Road are envisioned for long-term population and employment growth

#### Constraints

- Would increase the intensity of use on the site
- Potential re-orientation or relocation of one or more soccer fields may be required for an expanded arena to fit onsite







# NHCC: Existing Conditions

- Single-pad arena built in 1948
- Embedded in New Hamburg, adjacent to residential areas and Norm S. Hill Park
- A portion of the site is in the Nith River floodplain
- Building Condition Assessment finds the facility in fair to good condition
- Does not meet current standards for persons with disabilities









# NHCC: Opportunities & Constraints

### **Opportunities**

- Sentimental value among certain residents
- Provides a level of service directly in New Hamburg

#### Constraints

- Limited on-site parking
- Rink size is smaller than NHL-regulation
- Number and size of dressing rooms is inadequate
- Limited expansion potential due to size, grading and floodplain
- Older building systems may require significant reinvestment to meet long-term environmental sustainability /climate action objectives
- Single-pad arenas do not achieve economies of scale in operation compared to multi-pad arenas
- Previous studies estimate up to \$6.5 million for a dressing room expansion, new mechanical systems and selected building improvements (2019 dollars)







# WRC: Existing Conditions

- Parks staff use a workshop and break room originally designed for arena staff
- Small fenced area on the north exterior wall for equipment along with unsecured material storage across from the north entrance to the aquatic centre
- Shared laneway between Parks Staff and the public







## WRC:

## Opportunities & Constraints

## **Opportunities**

- Central location and strong access to local transportation network
- Management, supervisors and front-line staff are all on one site

### **Constraints**

- Amount of space is inadequate for current and future Parks needs
- Workshop limits efficiencies due to small size
- Unsecured storage has led to theft and vandalism of fleet, equipment and materials
- Shared laneway creates conflicts with the public vehicles
- Inadequate space for staff lockers, changerooms, showers, lunchroom
- Potential relocation of some soccer fields may be required for an expanded operations to fit onsite





## **Site Evaluation**

### **WRC**

- Area to the east presently occupied by mini soccer fields would have sufficient space for a building and storage (would require relocation of the fields to another park)
- The two undeveloped areas by the entrance off Nafziger Road may create sufficient space but would likely require relocating the entrance to the complex and/or relocation of some parking (and creates the potential for conflict with public traffic)
- Area to the north of the community centre deemed unfeasible due to configuration and available space
- Unlikely to accommodate joint operations between municipal departments (i.e. space would be relegated to just Parks & Facilities)







# **Preliminary Directions**

That the Township of Wilmot:

- 1. Construct a third ice pad by way of expanding the Wilmot Recreation Centre, designed and oriented in a manner that also allows for a potential fourth ice pad if required to meet post-2031 arena needs.
- 2. Assemble potential new lands to construct a new Parks Operations Centre on the basis that the WRC is selected as the preferred location for the arena addition.





## Next Steps

- 1. Seek Council feedback regarding the existing conditions analysis and Preliminary Directions
- 2. Conduct Stakeholder & Public Consultation for an expanded arena at the WRC
- 3. Proceed with conceptual plans and costing estimates for the Preferred Options
- 4. Report back to Township Council in early 2022



Good evening, council.

The Township's by-laws, including the Procedural By-law that you are reviewing today, are living documents, and I am so pleased to see that you are open to amending them as circumstances change.

As our knowledge and experience improves, so should protocols during council meetings, such as correcting the terminology you – and we, the public – use to refer to the acknowledgement that's read at the beginning of meetings.

I was disappointed, however, to read the proposed changes to the time allotted for delegations. Applicants, such as those who are seeking the approval of zoning applications for gravel pits or residential subdivisions, are allowed 15 minutes to present their case. Members of the public, on the other hand, are limited to just five minutes each.

Tonight's staff report states, that "five minutes is consistent with many other municipalities and encourages a concise, fact-based presentation."

I have delegated at a Regional council meeting, where I was only allowed five minutes to speak, and I remember being grateful for the 10 minutes that Wilmot council allowed for similar presentations. It can take time to prepare a coherent argument that builds to a conclusion, and *sometimes* five minutes simply isn't enough. Incomplete is not the same as concise, and I don't believe that restricting a presentation to five minutes will guarantee that it is fact-based.

The report also says, "Delegations are provided the opportunity to submit additional written materials to further expand on their concerns." But that is equally true for applicants, and not just residents. I've sat through presentations where applicants have read their PowerPoint slides verbatim. My lighthearted suggestion would be to ban presentation slides that contain any words.

Community engagement between residents and council is not just a matter of handing you a bunch of documents. These council meetings are opportunities for us to speak with you directly, as a group. I know that in these COVID times, that sense of connection may feel fragmented while meetings are conducted virtually, but there is a big difference between emailing you a document, rather than addressing you directly in the horseshoe.

The staff report suggests that when topics are being discussed and neighbours are in agreement, they could consider joint presentations. I'm not convinced that an organized, single delegation should necessarily be given more weight than neighbours who appear as individuals. Even if there is repetition, doesn't that show that there is some consensus within the community?

Many residents who delegate are inexperienced when it comes to presenting in public, whereas for applicants, public speaking is often part of their job. They have resources available to them – such as personnel support and a budget – whereas it might take someone who lacks those resources and experience more time to get their point across.

When I appear before council as a delegation, I want to feel that I have been heard and respected, as an individual and as a resident of Wilmot. That is an opportunity and a privilege that I do not take lightly.

I'm asking council and staff to reconsider the distinction between how delegations by applicants and by members of the public are treated. Neither side of an issue should be given a time advantage over the other.

SUBJECT: GRT Route 77 Service Expansion

#### RECOMMENDATION:

THAT the Township of Wilmot support a service expansion for Route 77 Wilmot commencing in September 2022, as recommended in Region of Waterloo 2022 Proposed Budget Issue Papers, at an estimated increase of \$80,000 which will form part of the Regional tax levy to the Township.

#### SUMMARY:

This report outlines a proposed service expansion for Grand River Transit Route 77 throughout Wilmot Township.

#### BACKGROUND:

Route 77 service to Wilmot Township was introduced on a pilot basis in 2016, and became a permanent route effective April 1, 2017. The Township supported a further increase in frequency as part of the 2020 Municipal Budget. This would have roughly doubled the amount of service by adding a second vehicle, increasing the frequency of the service and improving its reliability. Prior to its implementation the COVID pandemic forced a change of plans and the Route 77 expansion, along with other transit service expansions, was put on hold.



#### REPORT:

With the end of the pandemic in sight and ridership starting to increase again, Regional staff are proposing to start making improvements to service across several routes in 2022. One of the proposals is to re-introduce the Route 77 service expansion.

While this route is a Regional service and funded under the Regional portion of the tax base, transit is area rated in the Townships. As a result, any costs for the service in the Township are fully funded by Township ratepayers.

Continued expansion and development of Route 77 is supported Township Official Plan policies requiring infilling and intensification to form an increasing component of residential growth in the Township.

Indeed at this time Route 77 is a key driver in the ability of the Township to not only attract, but also sustain intensification projects within the Route 77 corridor through Baden and New Hamburg.

In turn those projects drive ridership which will further support the future extension of services.

Service changes are normally introduced in September and the anticipated impact on the overall 2022 Regional Transit budget is estimated at \$80,000 for this additional service. This estimate is based on the 2020 budget numbers adjusted up to account for the hourly cost figure for 2022.

Mr. Blair Allen, Supervisor of Transit Development for the Grand River Transit, will be present at the Council meeting to provide an overview of the proposed expansion to Route 77.

#### ALIGNMENT WITH THE TOWNSHIP OF WILMOT STRATEGIC PLAN:

This report is aligned with the strategic plan goal of Quality of Life, through Active Transportation and Transit. A specific action for supporting the expansion and further integration of public and active transportation networks and opportunities is reference in the current Strategic Plan.

#### ACTIONS TOWARDS UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS

This report and recommendation are aligned with the following UN: Sustainable Development Goals:

#### **FINANCIAL CONSIDERATIONS:**

Rural transit service via Grand River Transit (GRT) is funded through an area-rated structure. The overall Transit Levy in 2021 across the Region of Waterloo totaled \$123.6M, with \$621,000 allocated to Wilmot Township for specialized transit services (Kiwanis) and \$171,000 specific to Route 77.

The proposed service expansion would require an additional levy of approximately \$80,000 for the September to December 2022 timeframe. When annualized for a full calendar year in 2023 this service is expansion is estimated at \$230,000, excluding revenues from transit fares.

The total transit levy for Wilmot Township in 2022 will be determined following area rating calculations at the Region.



#### RECOMMENDATION:

THAT Report COR 2021-038, prepared by the Manager of Finance / Deputy Treasurer, regarding Municipal Drain Levies be received for information purposes.

#### **SUMMARY:**

This report outline activities that were recently completed on the Bayuk Drain Branch "A", Glen Shantz Drain 2020 and Nachurs Alpine Drain 2020. A drain levy by-law is required to assess benefiting property owners and submit an application to OMAFRA for grant funding.

#### **BACKGROUND:**

Under Section 74 of the Drainage Act RSO 1990 Chapter D.17, The Township of Wilmot is responsible for the maintenance of drains constructed under Township By-laws passed under the Drainage Act. The cost of drain maintenance is to be levied to lands and roads upstream of the point of maintenance in accordance with the current By-law applicable to the drain.

Additionally, by-law 2020-46 and 2020-32 authorized the completion of drainage works for the Glen Shantz Drain 2020 and Nachurs Alpine Drain 2020 respectively.



#### REPORT:

During 2020, drain repair and maintenance activities occurred on the Bayuk Drain Branch A while construction occurred on both the Glen Shantz Drain 2020 and Nachurs Alpine Drain 2020.

A levy by-law has been prepared to levy the associated costs to the assessed lands and roads of each drain, in accordance with the provisions of the applicable Engineer's Reports and By-Law, which adopted the Report. The levying by-law has been prepared, and is included within the by-law section of this Council agenda for approval.

As per the Drainage Act, Council is required to pass an actual cost by-law, and submit to the Ministry of Agriculture, Food and Rural Affairs (OMAFRA), in order to levy costs on landowners and receive any eligible grant funding.

Upon Council's approval of the by-law, staff will commence billing of the final assessments to the property owners, as outlined in Schedule B.

#### ALIGNMENT WITH THE TOWNSHIP OF WILMOT STRATEGIC PLAN:

#### ACTIONS TOWARDS UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS

The total drain activity cost is provided in the chart below. The chart outlines the total assessment, OMAFRA grant funding, and net assessment to benefitting landowners and the Township for each drain.

The assessment of these costs has been captured in Schedule B of the by-laws, and an application for 1/3 grant funding from OMAFRA for eligible properties, totaling \$29,793.29, will be submitted upon passage of the by-laws.

As per the levying by-laws, the Township of Wilmot has been allocated \$1,148.02 for the drains. These costs will be funded from general municipal drains operations.



# A BY-LAW TO PROVIDE FOR THE LEVY OF DRAIN MAINTENANCE COSTS ON THE BAYUK MUNICIPAL DRAIN BRANCH A IN THE TOWNSHIP OF WILMOT IN THE REGIONAL MUNICIPALITY OF WATERLOO

**WHEREAS** under Section 74 of the Drainage Act RSO 1990 Chapter D.17, The Township of Wilmot is responsible for the maintenance of drains constructed under Township By-laws passed under the Drainage Act;

**AND WHEREAS** the cost of drain maintenance is to be levied to lands and roads upstream of the point of maintenance in accordance with the current By-law applicable to the drain;

**AND WHEREAS** in 2020 the Township Drainage Superintendent undertook drain maintenance on the drains as listed in Schedule A attached:

**NOW THEREFORE** the Council of The Corporation of the Township of Wilmot enacts as follows:

- 1. That the maintenance costs of the drains listed in Schedule A shall be levied to the assessed lands and roads in accordance with the provisions of the applicable Engineer's report and the By-law which adopted the report as listed in Schedule A;
- 2. That for eligible lands the final cost levied shall be reduced by the amount of grants received from OMAFRA under Section 85 of the Act;
- 3. That the maintenance costs to be levied for the various drains listed in Schedule A shall be as outlined in Schedule B attached and the amounts shown in Schedule B shall be due within 30 days of the date of the invoice for the amount owing, after which time the amount due will be added to the Township Tax Roll;
- 4. That assessments in Schedule B less than \$15 shall be paid from general funds of the Township of Wilmot.

This by-law comes into force on the passing thereof and may be cited as the "2020 Drain Maintenance Cost Levy for Bayuk Municipal Drain Branch A" Bylaw.

#### NACHURS ALPINE MUNICIPAL DRAIN 2020 BEING AN ACTUAL COST BY-LAW TO AMEND BY-LAW NO. 2020-32

**WHEREAS** By-law No. 2020-32 of the Corporation of the Township of Wilmot provided for executing and completing the drainage works known as the Nachurs Alpine Municipal Drain 2020 at an estimated cost of \$55,000 and for levying the requisite sum of \$55,000 or such reduced sum after taking into account allowance and applicable grants;

**AND WHEREAS** the actual cost of the executing and completing the said drainage works is \$53,852.70;

**AND WHEREAS** it is expedient that By-Law No. 2020-32 be amended to provide for the reducing the assessment to the final amount of \$53,852.70;

**NOW THEREFORE** the Council of the Corporation of the Township of Wilmot amends By-Law 2020-32 as follows:

- 1. The final amount of \$53,852.70 shall be applied prorata to the assessments in "Schedule of Assessments" within the Narchurs Alpine Municipal Drain 2020 report dated July 27, 2020 which formed part of by-law No. 2020-32. The prorata assessments are outlined in "Schedule A" attached and forming part of this by-law.
- 2. The amount assessed to lands used for agricultural shall be reduced by the one-third grant available in accordance with Section 85 (a) (1) and 87 (1) (a) of the Drainage Act, R.S.O. 1990, Chapter D.17.
- 3. The amount assessed to lands which were granted an allowance under Sections 29 to 33 of the Drainage Act shall be reduced by the amount of the allowance as applicable in accordance with Section 62(3) of the Drainage Act.
- 4. This by-law shall come into force upon final passage thereof and may be cited as the Narchurs Alpine Municipal Drain 2020 Amending By-Law No. 2020-32.

**READ** a first and second time in this 22<sup>nd</sup> day of November, 2021.

#### GLEN SHANTZ MUNICIPAL DRAIN 2020 BEING AN ACTUAL COST BY-LAW TO AMEND BY-LAW NO. 2020-46

**WHEREAS** By-law No. 2020-46 of the Corporation of the Township of Wilmot provided for executing and completing the drainage works known as the Glen Shantz Municipal Drain 2020 at an estimated cost of \$86,500 and for levying the requisite sum of \$50,017 or such reduced sum after taking into account allowance and applicable grants;

**AND WHEREAS** the actual cost of the executing and completing the said drainage works is \$88,792.52;

**AND WHEREAS** it is expedient that By-Law No. 2020-46 be amended to provide for the raising by assessment the final amount of \$88,792.52;

**NOW THEREFORE** the Council of the Corporation of the Township of Wilmot amends By-Law 2020-46 as follows:

- 1. The final amount of \$88,792.52 shall be applied prorata to the assessments in "Schedule of Assessments" within the Glen Shantz Municipal Drain report dated October 21, 2020 which formed part of by-law No. 2020-46. The prorata assessments are outlined in "Schedule A" attached and forming part of this by-law.
- 2. The amount assessed to lands used for agricultural shall be reduced by the one-third grant available in accordance with Section 85 (a) (1) and 87 (1) (a) of the Drainage Act, R.S.O. 1990, Chapter D.17.
- 3. The amount assessed to lands which were granted an allowance under Sections 29 to 33 of the Drainage Act shall be reduced by the amount of the allowance as applicable in accordance with Section 62(3) of the Drainage Act.
- 4. This by-law shall come into force upon final passage thereof and may be cited as the Glen Shantz Municipal Drain 2020 Amending By-Law No. 2020-46.
