# **RECOMMENDATION:**

THAT Council approve Zone Change Application 04/22 made by Corre Enterprises Ltd., affecting Part of Lots 14 and 15, Plan 627 to amend the zoning of the property to permit residential units to exist in the building without a commercial use.

#### SUMMARY:

The subject property is designated Urban Core in the Township Official Plan and is zoned Zone 5 (Commercial) within the Township Zoning By-law 83-38, as amended. The property contains a mixed use building with 3 residential units and one commercial unit.

This application proposes to amend the zoning to permit residential units to exist in the building without a commercial use to allow a presently vacant commercial unit to be converted to a residential dwelling unit.

The Urban Core area designation is intended to provide for a full range of residential, commercial, institutional and other service uses. As such, providing flexibility within the current



zoning that reserves the ability for mixed uses within the building represents is appropriate and is supported by the policies of the Township Official Plan.

# **BACKGROUND:**

Notice of a Public Meeting was given to property owners within 120 metres of the subject lands on February 23, 2022. The following is a summary of comments received prior to the Public Meeting.

<u>Public</u>

No comments received.

#### Agencies

GRCA – indicating no concerns.

Region of Waterloo – recommending the inclusion of noise warning clauses relative to the CN railway be included in rental agreements.

WCDSB – indicating no concerns with the application.

#### REPORT:

The subject property is designated Urban Core in the Township Official Plan and is zoned Zone 5 (Commercial) within the Township Zoning By-law 83-38, as amended.

The current zoning of the property, Zone 5, permits residential units above a permitted commercial uses along with one residential unit on the main floor attached to a commercial use.

The property currently contains a mixed use building with 3 residential units and one commercial unit. The commercial unit on the main floor is vacant and the applicant's have indicated that there is a greater demand for use of the space a residential unit.

This application proposes to amend the zoning to permit residential units to exist in the building without a commercial use to allow a presently vacant commercial unit to be converted to a residential dwelling unit.

Eight current parking spaces, as illustrated on Attachment A, exceed the minimum requirements of the zoning by-law of 1.5 spaces per dwelling unit. As such, there are no alterations required to the property to accommodate the proposed conversion.

# ALIGNMENT WITH THE TOWNSHIP OF WILMOT STRATEGIC PLAN:

The approval of infilling residential uses maximizes the use of existing infrastructure and reduces the demand for additional greenfield lands to accommodate all residential



development which are both strategies in achieving the Township's goal to protect the natural environment.



# **RECOMMENDATION:**

#### SUMMARY:

A Tender was issued for grass cutting services contracts that was divided into three sections, New Hamburg, Baden and Other areas in the Township. The New Hamburg and Baden contracts are recommended to be awarded to All Terrain Landscaping Ltd. and the Other contract including New Dundee, Mannheim, St. Agatha etc., to Justin Polisak's Lawn Service.



#### **BACKGROUND:**

Grass cutting services in parks, sports fields, along trails and on boulevards has historically been contracted out to various service providers to ensure safe spaces for children and families to play, participate in sports and enjoy municipal properties.

In 2021, Council approved a one-year extension to the 2016-2020 grass cutting contracts for New Hamburg, Baden, and Other settlement areas. The original five (5) year contract expired at the end of 2020, and the one-year extension gave staff time to review the services and issue a new Tender (2022 - 04) for this important service.

#### REPORT:

Grass cutting is an important contracted service for the Township and these services are not able to be performed in-house as the Township does not have the staffing or equipment resources to perform this work.

In February 2022, tender 2022-04 was issued to seek contractors to perform grass cutting services in New Hamburg, Baden, and Other settlement areas for a five (5) year term commencing in 2022.

There were a total of seventeen (17) plan takers, and when the bidding closed on Wednesday March 2, 2022, there were a total of eleven (11) bids received through the Bids and Tenders online portal as follows:

The Tender provided the flexibility of awarding the three (3) contracts separately or to one or two contractors based on submitted pricing. This report recommends awarding the three contracts for grass cutting services as follows:

- New Hamburg Parks and Properties All Terrain Landscaping Ltd.,
- Baden Parks and Properties All Terrain Landscaping Ltd.,



• Other Township Parks and Properties - Justin Polisak's Lawn Service.

Each of the contractors being recommended for award held their prices for the duration of the five-year term. Parks, Facilities and Recreation staff will oversee the contractors' work and ensure the terms of the contract are being met and that workmanship meets the required standards as set out in the RFP.

#### ALIGNMENT WITH THE TOWNSHIP OF WILMOT STRATEGIC PLAN:

Awarding contracted grass cutting services aligns with the corporate goals of Quality of Life by providing safe, well-groomed parkland and sports fields for public access. This contract also meets the Responsible Governance goal for fiscal responsibility.

#### ACTIONS TOWARDS UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS:

Good Health and Well-Being.

#### FINANCIAL CONSIDERATIONS:

The Tender was split into three categories, New Hamburg, Baden and Other. Each of the categories required pricing for five years, 2022, 2023, 2024, 2025, and 2026.

The annual total for each of the five (5) years is \$105,750 net of HST and will be funded through the Operating Budget. By comparison, in 2021, \$107,510 was expended on grass cutting services. Although the contract allows for flexibility to adjust the number of cuts based on weather, the proposed annual pricing has decreased slightly from the previous contract, and is proposed to be held at a consistent rate for the five (5) year term.

#### SUMMARY:

This report is to provide Council with information to make a final informed decision for an alternative voting method for the 2022 Municipal and School Board Elections.

#### BACKGROUND:

Historically the Township of Wilmot has used the traditional paper ballot voting system. Since the 2014 Municipal Election, optical scan tabulators were deployed as vote-counting



equipment. Interested election workers from the community were recruited and provided training to assist with the election process.

The Municipal Elections Act, 1996 (MEA), states 'The Clerk of a local municipality is responsible for conducting elections within that municipality' but also requires certain elements of the election process to be approved by Council. The MEA requires a by-law be passed regarding the use of alternative voting methods, within the amended timeline made under the Municipal Elections Modernization Act, 2016 (MEMA).

Undertaking an alternative voting method requires that Council authorize electors to use such a method by passing a by-law on or before May 1st in the year of the election. This means that a Council resolution must be passed and a by-law adopted by May 1, 2022 to be effective for the 2022 Municipal Election.

At its Regular Council meeting on October 4, 2021, Council approved, in-principle, the alternative voting method of Internet combined with Paper Voting and directed staff to report back on vendor solutions and pricing.

# REPORT:

Staff, in cooperation with the Townships of Woolwich and Wellesley released a joint RFP, for alternative voting methods for the 2022 Municipal and School Board Elections. In total there were six (6) plan takers and four (4) proposals were received and evaluated by staff.

The team evaluating the RFP included those with experience in information technology, cyber security, financial management, front-line election management, and election administration.

Information and Legislative Services staff, along with staff of the partnering Townships attended demonstration presentations by three (3) vendors: Scytl, Intelivote and Simply Voting. A demonstration from the fourth vendor was not requested as they did not meet the RFP requirements. All three (3) online voting service providers offered solutions that could meet the needs of an online and telephone voting experience.

The evaluation of the RFPs by the Townships of Wellesley, Wilmot and Woolwich indicated Scytl Elections Technologies as the successful proponent for all three (3) municipalities. Subject to approval of by-law No. 2022-12, staff will begin discussions with Scytl to execute the agreement and affirm the schedule.

Wilmot Township staff will realize many benefits working alongside the Townships of Wellesley and Woolwich with Scytl. For both Wellesley and Woolwich, this is their second election using online and telephone voting. The Clerk's Departments for all three (3) municipalities will be collaborating on preparing practices and procedures necessary for the conduct of the election. Scytl has created a municipal working group for Returning Officers and their staff to share best practices and act as resources for one another.

The Township of Wilmot has adapted several services to an online platform as a result of the COVID-19 Pandemic. Although it appears the Pandemic is improving and many protocols are being lifted, there is still a recognized comfort level to continue online services as a way of staying healthy and safe. During the summer of 2021, staff conducted a survey of residents asking their preferred method of voting and 53% of respondents preferred Internet Voting. Staff are continuing to recommend two (2) vote casting and vote counting methods of online and paper voting. As noted in staff report ILS 2021-35, advance voting days will be held in early October and utilize Paper Vote casting, with a hand count by election workers. Following those advance voting days, a multi-day internet voting period will take place with the final Internet Voting Day on Election Day, October 24, 2022.

# **2022 Municipal Election Key Dates**

For the April 11, 2022 Council Meeting, staff will be providing Council with updated governance documents pertaining to the Use of Municipal Resources in a Municipal Election and Vote Recount Procedures. Additionally, this report will provide Council with a summary of key dates relative to a Ward Boundary Review and cost estimates for such a review.

March 31: No by-elections shall be held after this date.

**April 30**: Last day to establish rules and procedures regarding the use of municipal resources during the election campaign. This is a policy requirement that began with the 2018 Election.

# 

**May 1**: Last day to pass a by-law to use vote counting equipment or alternative voting methods. Also, last day to pass a by-law that outlines the circumstances where the Clerk shall conduct a recount.

May 2: Nomination and registration period begins for candidates and third-party advertisers.

**June 1**: Last day to establish procedures and forms for the use of any voting and votecounting equipment or alternative voting method.

July 31: Last day for MPAC to deliver the preliminary voters list.

**August 19**: Nomination Day. Nominations may only be filed or withdrawn between 9:00 am and 2:00 pm. 2:00 pm on this date is the final opportunity to file or withdraw a nomination. Any person in line to file by 2:00 pm will be allowed to file.

August 22: All nominations to be examined, certified, and declared by the Clerk.

**September 1**: Last day for reproducing the voters' list for those entitled to receive them (candidates and school boards). Also, revision period begins where a voter may have their information amended upon application.

September 24: First possible day to hold an advance vote.

**September 26**: Last day to provide a copy of the interim voters list to each person who previously received a copy. Also, the last day for the Clerk to provide candidates and third party-advertisers with campaign maximums.

**October 1**: Last day for council to establish a compliance audit committee for the 2022-2026 term. Wilmot is part of a joint initiative across the Region, plus Guelph, to create a pool of Municipal Elections Compliance Audit Committee (MECAC) Members that can be called upon if needed. MECAC strictly reviews inquiries relating to Candidate's Financial Statements, nothing else.

October 21: Last day for third party advertisers to file their notice of registration.

**October 23**: Last day to provide candidates with notice of penalties related to campaign finances and refund filing fee. Also, last day to make the Accessibility Plan available to the public. This is general done as part of a Council report, much earlier than this date

October 24: Voting Day.

October 25: Clerk to declare the results and provide information to the public.

November 15: New term of office commences.

November 21: Inaugural Council Meeting.



#### Lame Duck Provisions

Lame Duck could begin on August 20, 2022, or October 25, 2022. The Township could end up in a Lame Duck situation if the new Council will be less than <sup>3</sup>/<sub>4</sub> of the outgoing Council.

This means that the Township is in a Lame Duck situation if more than one member of the current Council has chosen not to seek re-election, which would start a Lame Duck period on August 20, 2022, or more than one member of the current Council was not re-elected, which would start the Lame Duck period on October 25, 2022. These provisions are included in Section 275 of the *Municipal Act, 2001*. The restrictions during a Lame Duck period are:

- No appointments or removals from office any officer of the municipality;
- Hiring or dismissing any employee;
- Disposition of real or personal property with a value of more than \$50,000 at the time of selling that was not previously budgeted for as part of the current year budget; and,
- Unbudgeted expenditures or incurring liability over \$50,000.

The above four (4) restrictions do not apply in the event of an emergency or when authority has been delegated to a person prior to Nomination Day.

#### ALIGNMENT WITH THE TOWNSHIP OF WILMOT STRATEGIC PLAN:

An alternative hybrid voting method aligns with the Strategic Plan Goal of Community Engagement of belonging and support for community as well as the Goal of Quality of Life through accessibility and inclusivity and the Goal of Responsible Governance through active communications.

#### ACTIONS TOWARDS UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS:

By nature of the Information and Legislative Services department, this department is often the conduit through which Council and the corporation has the capacity to impact in a positive way several of the United Nations Sustainable Development Goals.

Specific to the actions of the department itself, Goal 16, Peace, Justice and Strong Institutions targets include:

- 16.7 Ensure responsive, inclusive, participatory and representative decision-making at all levels; and,
- 16.10 Ensure public access to information and protect fundamental freedoms, in accordance with nation legislation and internal agreements.

#### FINANCIAL CONSIDERATIONS:

Costs associated with the municipal election are funded from the Elections Reserve Fund, which is built through annual levy allocations.

The total cost of the 2022 Municipal Election was estimated at \$31,200.

Through participating in a joint-procurement process, staff have awarded the contract to Scytl as a discounted cost of \$16,281.60 (net of HST rebate). This will leave just under \$15,000 within the 2022 Budget for remaining election costs.

# **RECOMMENDATION:**

THAT Report receive report DS 2022-010 for information; and further,

THAT Council consider whether they wish to adopt a resolution in support of the Halton Hills request for a moratorium on the consideration of new gravel pit applications in the Province of Ontario.

#### SUMMARY:

Staff have reviewed the Halton Hills resolution (Attachment A) and formatted it for consideration by Wilmot Council, per the direction of Council (Attachment B).

It is important to note that a resolution supporting a Provincial Moratorium has no impact on the ongoing processing of local applications. That would only occur if the Province decided to implement such a moratorium.

Staff are aware that North Dumfries has supported the Halton Hills resolution by crafting a resolution of their own which is attached to this report (Attachment C).



Woolwich Council has indicated support for the North Dumfries motion with the final wording of their resolution not confirmed at the time of writing this report.

#### BACKGROUND:

The resolution of the Town of Halton Hills requesting that the Province of Ontario impose a moratorium on the consideration of new aggregate applications was included under Correspondence on the February 28<sup>th</sup> Council Agenda.

Staff were directed to bring a report to Council on March 28<sup>th</sup> with the Halton Hills resolution formatted for Wilmot's consideration.

#### REPORT:

The Halton Hills resolution (Attachment A) calls for a pause in the consideration of new aggregate extraction applications across the Province pending a broad consultation process with a wide variety of stakeholders.

The Provincial consultation envisioned by Halton would:

- Develop criteria and processes for determining the need for new gravel licenses;
- Update policies/procedures for mining below the water table;
- Develop new guidelines for reprocessing to ensure sustainable aggregate supplies;
- Recommend a fair levy for gravel mining including compensation to the local community for the full environmental and infrastructure maintenance costs of extraction and distribution of aggregate; and,
- Provide greater weight to municipal input to lessen the social impacts from mining operations and trucking through local communities.

Of particular note in the resolution is the rooting of the concern in the current limitations imposed on municipalities by the Provincial Policy Statement (PPS) which specifically prohibits the consideration of existing supply and demand as a factor in deliberations on new gravel pits.

Section 2.5.2 Protection of Long-Term Resource Supply of the PPS states,

2.5.2.1 As much of the mineral aggregate resources as is realistically possible shall be made available as close to markets as possible.

Demonstration of need for mineral aggregate resources, including any type of supply/demand analysis, shall not be required, notwithstanding the availability, designation or licensing for extraction of mineral aggregate resources locally or elsewhere.

As such, in the absence of a moratorium implemented by the Province, the Township is unable to consider supply and demand of aggregates as part of its review of zoning requests.

While the Planning Act does provide tools to municipalities to halt the consideration of applications where local policies are out of date or require review through an Interim Control Bylaw there is no similar mechanism available when a local Council feels Provincial Policies require review.

As such, should Council support the need for a moratorium it is important to note that it would have no actual impact on the processing of existing applications or future applications in Wilmot Township – unless the Province chose to impose such a moratorium.

It would appear from a search of media correspondence respecting the Halton Hills resolution that the resolution has not gained any significant level of traction among other municipalities at this time. In reviewing the Halton Hills resolution Township staff have a number of concerns with the broad generalizations respecting the negative impacts of aggregates and the lack of balancing concerns with any indication of the many important benefits that aggregates provide. In particular, as the Township of Wilmot is a current owner of a small aggregate operation, Council should consider the potential impact of endorsing the exact wording of the Halton Hills Moratorium resolution.

Having said that, per the direction of Council the Halton Moratorium resolution has been formatted to align with Wilmot specific circulations in the recital and is attached as Attachment B to this report.

It may be of interest to Council that the Township of North Dumfries passed a similar resolution to the Halton Hills resolution supporting a moratorium on new gravel pit applications.

The North Dumfries resolution is attached as Attachment C to this report and softens some aspects of the resolution by limiting the absolute nature of the recital respecting environmental impacts. The resolution does however remove the specific recital respecting First Nations consultation contained within the Halton Hills resolution.

The Township of Wilmot currently has a total of fifteen (15) licensed pits covering approximately 544ha. While the licenses would permit the annual extraction of approximately 6 million tonnes of aggregate, in 2020 the total extraction was approximately 1.365 million tonnes.

Nothwithstanding the existing licensed supply in Wilmot, in the absence of a moratorium implemented by the Province, the Township is unable to consider supply and demand of aggregates as part of its review of zoning requests.

*ii)* Recommends updated policies and restrictions for aggregate extraction below the water table to reflect current groundwater sciences;

*iii)* Assesses the cumulative impacts of aggregate operations in terms of off-site impacts to environmental systems; the groundwater regime and baseflow contributions to area watercourses, wetlands, etc; area habitat including corridors; traffic along haul routes; and, dust and noise emissions;

*iv)* Develops new guidelines for reprocessing / recycling of concrete and asphalt products in order to ensure sustainable aggregate supplies;

v) Recommends a fair levy for aggregate extraction that includes compensation for the full environmental and infrastructure maintenance costs to the local community of extraction and distribution of aggregate;

vi) Provides greater weight to the input by local municipalities to lessen the social impacts from aggregate extraction and truck haul routes through their communities

# **RECOMMENDATION:**

THAT Report PFRS 2022-13 be received for information; and further

THAT Staff be directed to explore the opportunity to relocate the side rails of the Bridge Street Bridge to the Mike Schout Wetlands; and further

THAT Staff be directed to work with Mr. Schout and Schout Corporation to seek sponsorship and/or donations to cover the cost of relocating and installing the Bridge Street Bridge side rails within the Wetlands; and

THAT staff be directed to report back to Council should sufficient funds be raised to include components of the Bridge Street Bridge in the Wetlands project design.



This report seeks support to explore moving the side rails of the Bridge Street Bridge to the Mike Schout Wetlands Preserve and incorporate it into the pedestrian boardwalk design as an aesthetic feature. This proposal is dependent on utilizing some of the funds identified in the Bridge Street Bridge Capital project for tear down and potential transportation to the Wetlands site and obtaining sponsorship and / or donations to fund the engineering and installation of the side rails within the Wetlands.

#### **BACKGROUND:**

On January 17, 2022, staff report PWE 2022-02 which recommended the removal and replacement of the Bridge Street Bridge was approved by Council. The following formed a key part of the resolution passed by Council:

THAT staff be directed to further investigate the relocation of the existing structure within the Township, and prior to calling the tender for construction, report back to Council with a recommendation.

Through the course of the Environmental Assessment process in Q4 2021, staff held discussions with the Heritage Wilmot Advisory Committee, specific to the relocation option of the structure. The committee specifically requested investigating the relocation of the bridge, or a portion of the bridge to a trail or to the Mike Schout Wetlands Preserve project in a staff meeting in December 2021. At that time leading up to the Council report in January 2022, and in the time following, staff have been working through logistics to determine a feasible framework for Council to consider the opportunity of relocating a portion of the structure to this location.






# REPORT:

The Mike Schout Wetlands Preserve project includes a planned 1.5 km boardwalk to complement the development of the wetland's ponds, tree planting and pollinator plantings. The project is scheduled to be complete by the end of the summer or early autumn. During a recent Wetlands discussion, staff indicated to the team that the Bridge Street Bridge was being replaced in 2022. Mr. Schout and the design team expressed interest in exploring the possibility of relocating a portion of the bridge to the Wetlands. The team felt this location was ideal for showcasing and preserving the side rails over a portion of the planned boardwalk. The suggestion focused on the side rails and some of the overhead structural supports versus the whole bridge. This would allow for easier dismantling and transportation to the site.

As a result of the interest in this opportunity, staff reached out to the Grand River Conservation Authority (GRCA) to seek their input into the impact that adding this feature to the Wetlands would have on the existing permit for this project. GRCA staff indicated they had no issues with this addition should it be approved, and that a minor amendment to the permit would be required as well as a refined plan showing the proposed location, details about any supporting grading and pier placement. GRCA staff expressed that the bridge is an important cultural feature within the Grand River watershed and supports the national status of the Grand River and its major tributaries (including the Nith River) as Canadian Heritage Rivers.



The proposed location for the bridge side rails is approximated in the photo above and will span a small tributary within the Wetlands that is along the planned boardwalk. Although the bridge is approximately 164 feet long and 14 feet wide, the 55-acre property is ideal to host



this impressive structure without it looking out of place and will create a focal point within the property.

The approved Capital project to remove and replace the Bridge Street Bridge includes funds for the demolition/dismantling of the existing bridge, and anticipated storage or relocation costs. Should Council support this report, Parks, Facilities and Recreation staff will work with Public Works and Engineering staff to seek detailed costs for dismantling the bridge and potentially relocating it to the Wetlands.

Mr. Schout has indicated that seeking sponsorship and/or donations to support the cost of reinstalling the side rails of the bridge within the Wetlands would be the preferred funding approach as this component was not contemplated when the project commenced. Staff will work with Mr. Schout to assist with this process should Council approve this report.

Staff will also present this concept to Heritage Wilmot to seek their support and assistance with the fundraising should they support this idea.

#### ALIGNMENT WITH THE TOWNSHIP OF WILMOT STRATEGIC PLAN:

Relocating this culturally significant bridge to the Mike Schout Wetlands supports the Strategic Goals of Quality of Life, Responsible Government and Environmental Protection.

Development of the Mike Schout Wetlands Preserve was identified as a specific strategic action within the Council approved Strategic Plan.

# ACTIONS TOWARDS UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS:

Good Health and Well-Being.

#### FINANCIAL CONSIDERATIONS:

The amendment to the GRCA permit will cost the Township \$90 and will be funded through the Parks and Facilities operating budget, while costs to dismantle the Bridge will be included in the Bridge Street Bridge capital project.

Costs for re-installation of the bridge are not expected to impact the tax base as efforts will be made to find local sponsors and/or donors to fund the installation. Should any costs be required for this bridge relocation, staff will bring a report back to Council to seek approval.

THAT staff be directed to proceed with public consultation on the concept design including an online review and comment opportunity on the Township website, and a review opportunity by the Grand River Accessibility Advisory Committee, the New Hamburg Board of Trade, the Wilmot Trails Advisory Committee, and neighbouring businesses; and

THAT staff be directed to bring the 100% design drawings back to Council for approval while incorporating consultation feedback where possible, prior to tendering the project for construction.



# SUMMARY:

This report presents the 90% complete concept design for the Nith River Promenade and Trail Project as prepared by WSP with input from Township staff. Staff are seeking Council approval, in principle, of the concept design in order that staff can begin the public consultation process and seek feedback from key stakeholders and the general public prior to tendering construction.

# BACKGROUND:

The Nith River Promenade and Trail in downtown New Hamburg span the banks of the Nith River between Kirkpatrick Park and the Hartman Bridge. The Nith River Promenade and Trail project will provide enhancements to this distinctive, centrally located, accessible amenity for community members and visitors to gather for private and community-led events, participate in recreational activities made possible by the surrounding parklands and adjoining Nith River, connect to the downtown core of New Hamburg, and enjoy the views of the New Hamburg Heritage Water Wheel and Nith River Reservoir Dam.

The area surrounding the Nith River Promenade and Trail endures annual flooding which increases erosion challenges along the promenade and required a thorough redesign in collaboration with the Grand River Conservation Authority (GRCA). The objective of the proposed promenade and trail layouts aim to improve the slope and construction of the pathways and features which do not currently meet all accessibility standards and improve access to the Nith River for water sports and pedestrian use which is expected to encourage patronage in the adjacent commercial district.

Rehabilitating the existing trail was included in past Ten-Year Capital Budget approvals, and in late 2019, the Township received conditional approval of funding towards "New Hamburg Core Enhancements – Nith River Pathway and Erosion Control" under the Rural Economic Development (RED) program. In addition, \$200,000 in grant funding under the Canada Community Revitalization Fund (CCRF) has been applied for to fund a portion of the construction as per the current Ten-Year Capital Budget. Staff are continuing to work with the representatives from the Federal Economic Development Agency for Southern Ontario (FedDev Ontario) in the hopes to be successful in our application.

In 2021, WSP was awarded a contract for design of the Downtown New Hamburg Nith River Promenade Rehabilitation, as per their proposal received March 19, 2021.

# **REPORT:**

This report includes a 90% concept design prepared by WSP for Council's review and consideration attached as Appendix A. Intended to enhance the waterside experience along the Nith River, while providing an excellent view of the Waterwheel and reservoir features, this design includes the following features:



- Upgrading and relocating trail lighting on the East side of the river to enhance visibility for trail users after sundown, improve the aesthetics of the Nith River Promenade and Trail to compliment the adjoining Kirkpatrick Park, and provide durable light poles able to withstand the flooding and ice floes from the Nith River during high water and spring thaw events.
- Decreasing the slope of the ramps that connect the trail to the promenade to provide 5% grading or less and removing steps within the trail to increase accessibility.
- Enhancing the upper gathering platform to increase usability and views of the New Hamburg Heritage Water Wheel including relocating the existing electrical panel, redesigning the guardrails, and replacing the interlock with concrete.
- Resurfacing the Nith River Trail from the Cenotaph to the Kirkpatrick Park trail with new, 3m wide asphalt.
- Adding armour stone retaining walls to best utilize the naturalized areas to create 450mm deep planting beds with soil, mulch and coir mat for future garden beds and tree planting.
- Constructing a lower gathering area with armour stone seating to allow users the opportunity to rest and relax next to the river's edge.
- Raising and reconstructing the promenade pathway with concrete to significantly reduce ice damage and eliminate the depressions and voids caused by undermining.
- Installing subangular rip rap for slope stabilization, erosion control, and esthetics.
- Planting wildflower riverbank seed to deter geese, encourage pollinators and reduce landscape maintenance.

The GRCA has been continually engaged throughout the design stage and is supportive of the overall design concept. An application to the GRCA for their Development, Interference with Wetlands and Alterations to Shorelines and Watercourses Permit is currently in process.

Staff is seeking Council approval, in principle, of the 90% design package and support to initiate public consultation regarding the proposed design. Included in the public consultation will be an online commenting period, input from the Grand River Accessibility Advisory Committee, the Board of Trade, the Wilmot Trails Committee, and neighbouring businesses prior to finalizing the design. Once the design is updated to include the public and key stakeholder input, a final, 100% design package will be brought back to Council prior to tendering for construction.

# ALIGNMENT WITH THE TOWNSHIP OF WILMOT STRATEGIC PLAN:

Improvements to the trail, including increased accessibility, enhanced erosion control, and a design incorporating stakeholder engagement, furthers the Townships goals of Quality of Life, Environmental Protection and Community Engagement.

Implementation of the recommendations within the Trails Master Plan was identified as a specific strategic action under the Council approved Strategic Plan.



# **RECOMMENDATION:**

THAT Council accepts Report No. PWE 2022-08 for information; and further,

THAT Council approve the amendment to the Traffic and Parking By-law, By-law No. 2016-52, for Schedules "1", "2", "3", "4", "5", "7", "10", "11", "12", "13", "15", "16", "18", "22", and "25" and the addition of Schedule "26".

# SUMMARY:

This report outlines the Traffic and Parking By-law purpose and enforcement requirements. It discusses the findings from a series of sign inspections and Asset Management inventory updating. It also describes the by-law, signage responsibility of the regional and boundary road intersections, and use of the emergency and safety provision under the by-law. This report then addresses the actions recommended to Council.





As part of the Asset Management Ontario Regulation 588/17, staff started field reviews to identify and document asset inventories of highway regulatory signage, and to review for consistency with the current Traffic and Parking By-Law. Staff noticed a number of inconsistencies in the field when reviewed with the By-Law schedules. As such, staff undertook a comprehensive review of installed signage with the By-Law schedules to review accuracy and consistency. The last general review of the By-Law took place as part of the By-Law update in 2016 (Report No. CL2016-20). The current review of the Traffic and Parking By-Law included the following:

- Residential land development that has occurred within Wilmot
- Update of capital project improvements
- Heavy truck prohibitions on bridge structures
- Updates to Boundary Road Agreements
- An audit to ensure errors and omissions were eliminated
- Exercising emergency and safety provisions allowed under the by-law

The area municipalities in the Region of Waterloo have coordinated their Traffic and Parking By-Laws to provide consistency in structure, phrasing, and content across the Region. The By-law is organized by Parts and Schedules with the Parts explaining the components or restrictions, and the Schedules list the location where that corresponding component or restriction occurs.

Township By-law Enforcement staff and Waterloo Regional Police are only able to enforce traffic restrictions if certain conditions are met, generally being legal signs are posted; legal signs are identified in the Ontario Highway Traffic Act; and the legal signs are described within the appropriate Municipal By-law Schedules.

# REPORT:

In the Spring of 2021, traffic and parking signs in the Township of Wilmot were inspected to update the Asset Management inventory as per Ontario Regulation 588/17. It was noted that the current Traffic and Parking By-law contains described Schedules that do not accurately reflect the signage changes in the Township. As such, the Traffic and Parking By-law is due for amendments following several years from the previous review of the By-law and inconsistencies in schedules and installed signage. Staff recommend that Council adopt the amendments to By-law Schedules 1, 2, 3, 4, 5, 7, 10, 11, 12, 13, 15, 16, 18, 22, and 25 and the addition of Schedule 26 to reflect the changes to regulatory signage on Township public highways, as follows:

- A number of installed signs were found to be excluded in their respected by-law schedule. The additions to each respective schedule are outlined in Attachment A.
- A number of signs were not installed based on the location described by the sign's respective by-law schedule. Those found to be uninstalled were found either in mapping records or in By-law 2016-52. In the case of missing signage, the by-law items were coordinated for installation through Transportation (Roads) Operations staff. These

signs will be installed as described in the original by-law schedule. These are outlined in Attachment A.

- Two minor intersections were identified as uncontrolled intersections during inspections. Riverview Ave intersecting Hillfield Drive in New Hamburg, and Hastings Court which intersects itself in Baden. Both intersections were brought to the attention of Wilmot Roads Supervisor. Actions have been taken to resolve both intersections. Signs were installed and added to the appropriate by-law schedule under this report.
- A number of signs located in areas of subdivision development are not covered by the current by-law, but had been previously installed. These signs have been identified and added to the proposed amended by-law schedules.
- Through the reconstruction of the Wilmot Street capital project, on-street parking was introduced for angled, accessible and electric charging station parking in front of Kirkpatrick Park. These signs have been identified and added to the proposed amending by-law.
- Wilmot has and will be entering into boundary road agreements with other municipalities. These agreements will outline which municipality is responsible for maintenance and signage of sections of the boundary roads. Wilmot Township roads that intersect a boundary road will remain in the Township by-law. Intersections on a section of road that Wilmot Township is responsible for under the boundary road agreement have been added in this by-law update. Regional intersections or other boundary roads under the administration of the adjacent municipality are not represented in the schedules.
- Three bridge structures in the Township were identified as having load restriction signs not currently contained within the by-law schedules. This update to the by-law will also see the addition of a new schedule, Schedule "26" Heavy Truck Prohibition on Bridge Structures.
- Some general maintenance updates for the Traffic and Parking Bylaw include additional "no parking" signs on Elizabeth Street, Schneller Dr., Stiefelmeyer Crescent, relocation of a school bus loading zone along Hunter Street. These were updated based on the provision under the by-law for authority of signage based on safety or emergency situations.
- Administrative update to the fine schedules in the by-law for three set fines previously approved by the Province. The penalties noted were previously approved by the Province following Council's adoption of By-law 2019-26. No new penalties are being introduced as part of this amending by-law. The set fines are handled by the By-Law department but need to be updated into the respective schedule within the Traffic and Parking By-Law that engineering staff update.



# Use of the Emergency and Safety Provision

Engineering and By-Law staff have received a number of complaints about parking situations on narrow roads or horizontal curves or bends in the road that do not allow space for emergency service vehicles and large service vehicles and equipment. Historically, staff have relied on the Highway Traffic Act (HTA) in these scenarios, in which police can enforce Section 134 of the HTA to enforce or remove vehicles blocking the regular flow of traffic.

Under Part III Section 2. Authority under the By-Law, there is provision for emergency and safety situations. Part (b) notes the following:

The Director of Public Works (and Engineering) is authorized, notwithstanding the other provisions of this By-law, to place, erect, maintain, move and remove such traffic control devices and traffic control signals as are required for reasons of emergency or safety or for an activity for which the Region or the Municipality has granted a permit.

In consultation with area municipalities in the Regional Traffic Coordinators group, it is understood that the authority under the bylaw is utilized to introduce restrictions in scenarios where emergency services or large service vehicles can't safely pass-through the right of way due to parking, rather than relying on the HTA scenario to undertake enforcement or removals. Using the By-Law would provide authority for enforcement to municipal bylaw officers, which would allow for more timely and effective enforcement scenarios for parking that blocks emergency vehicle passage. It would also directly bring attention to the road user of parking restrictions and best-practice for parking etiquette.

As such, staff will be utilizing this provision in more scenarios, with the following general flow of process once a parking restriction complaint or concern under the safety or emergency provision is received:

- 1) Staff conduct initial, brief screening based on physical and use characteristics of the road to determine if it meets general safety or emergency criteria;
- 2) If it meets criteria, review adequate restriction locations based on the physical environment;
- 3) Undertake installation of signage required to address the safety or emergency; and
- 4) Notify properties immediately fronting the restriction area of the restrictions and provide a Council report date that staff intend to have the adoption completed.

In this scenario, the intention is to use the authority under the bylaw to address the emergency and safety provision at the earliest opportunity and allow for the public to provide input to Council, if they wish. This scenario differs from other parking change requests in that, if a matter is brought forward that doesn't meet the safety or emergency provision, staff undertake a general commenting period in the affected area before taking a report to Council. This allows for input before a comprehensive report to Council is provided.



There are no prescribed notification requirements within the *Municipal Act, 2001,* associated with the Traffic and Parking By-Law. The Township's Notice By-law requires that the item be listed on the agenda of the Regular Council Meeting at which it is being considered.

The Engineering work program in the coming months will include creation of standards for parking restriction reviews, establishing restrictions in existing neighbourhoods and new developments, as well as traffic calming. Previously, the Traffic and Parking By-law review and amendments were not performed on a regular schedule. However, moving forward staff plan to perform an annual review of this by-law to include signage within new registered subdivisions, capital project initiatives, and general maintenance for that year. In cases where emergency or safety provisions are utilized, staff will provide a report for adoption at the earliest opportunity following the installation of signage.

# FINANCIAL CONSIDERATIONS:

Financial considerations for this report include staff time for inspection, administration as well as on site work for signage removal and installation as per Attachment A.

Staff estimate a cost of approximately \$530 per sign including staff time, signage material and field installation labour and equipment costs. With approximately fifty (50) signs needing to be removed and installed, the financial implications are estimated to be approximately \$25,000. These costs are covered under the existing Roads Operating budget.

# RECOMMENDATION

THAT the Community Services Section of Coordinated Committee receive the Chief Administrative Officer's report on the County of Simcoe Regional Government Review Service Delivery Task Force Fire Services Review for information;

FURTHER that the Community Services Section of Coordinated Committee authorize the Chief Administrative Officer to inform the County of Simcoe that the Town of Wasaga Beach supports recommendations nine and ten of the Fire Service Review report.

# BACKGROUND

The County of Simcoe established a Service Delivery Task Force Committee of County Council members to undertake reviews of the following services to determine if efficiencies could be found leading to improved services to tax payers. The services being reviewed are:

- Conservation Authority Services
- Fire Services
- Land Use Planning Services
- Library Services
- Transit Services
- Water and Waste Water Services
- Storm Water Management Services completed, no further action required
- Legal Services completed, no further action required

The subject of this report is the review of Fire Services.

The County engaged a third-party consultant to conduct a comprehensive review of Fire Services in the County of Simcoe, identifying possible efficiencies and preferred Service Delivery models including regional and sub-regional service models.

Through an RFP process, Pomax Consulting Inc. (Pomax) was selected by the County to complete the review. The Pomax team commenced the project and municipal engagement in May 2021.

On December 6, 2021 the County of Simcoe Regional Government Review Service Delivery Task Force received the final report and passed a resolution requesting that the report be sent to individual municipal Councils for review and comment.

The ten recommendations tabled with the Task Force are as follows:

- "Share fire chiefs wherever possible. Examples of this include Innisfil and Bradford-West Gwillimbury, and Penetanguishene and Midland. There is an expectation that the number of responses will decline in the next few years as the province implements Medical Priority Dispatch System (MPDS). An advantage of sharing fire chiefs may be that the joint chief will find realistic ways to rationalize training, prevention, public education, and stations. Essa Township has an opportunity to share a fire chief with a neighbouring community or even amalgamating.
- 2. Share recruitment, intake, selection, training, and equipment in the same manner as takes place in North Simcoe. Duplication of these processes can be expensive. Sharing also supports consistency so that when the time comes that firefighters from different departments have to work together at mutual aid or other major incidents, they are familiar with common practices.
- 3. Share public education and prevention resources. This may not save money but may accomplish consistency in neighbouring communities and may enhance some communities that have inadequate resources.
- 4. Where possible consolidate fire services. This is not a minor step but it is one that has been accomplished before when municipalities amalgamate or a decision is made that shared services is best for a community https://lincoln.ca/news/2021/06/media-releasetowns-lincoln-and-grimsby-embarkshared-fire-service-pilot-project.
- 5. Several fire departments, during interviews, discussed establishing training centres some with the perspective of providing services for a fee to other fire departments. Prior to taking those steps, partnerships should be discussed to defray costs and to determine the best location for training centres. Training centres that are established with the objective of defraying costs by renting to other fire departments do not have a history of success.

- 6. Prior to considering building a new fire station, undertake a needs analysis including response modelling and incident type. Fires may be an impetus for establishing a new or additional fire station but sometimes medical incidents are held out as part of the justification. Fires are on a downward trend. It is possible medical responses will also trend downwards. Schedule 1 RGR 2021-357 Page 28 Simcoe County Fire Services Review Final Report Part 1 Page | 27
- 7. Where possible, consider contracting services with a neighbouring municipality. Ramara Station 2's response area is a possible opportunity as are responses to areas that border other full time fire departments.
- 8. Employ the precept of closest or quickest vehicle responds. Although some form of cost per call may have to be worked out using the closest fire resource delivers service sooner.
- 9. Obtaining and understanding fire department data and information, particularly outcome information to answer the question "Why are we doing what we are doing?" should be the primary objective of all municipalities. It does not exist now notwithstanding the efforts of some departments who are attempting to secure information. This is a major undertaking that is not realistic for individual departments but could be provided by the county on a cost recovery basis. We recommend that municipalities work with the county to obtain that service, or the county should establish the service and offer it to those municipalities who see it as an advantage. During our interviews several CAOs envisioned the county as being the data and information centre.
- 10. We recommend that representatives of Simcoe County and the municipalities form a committee to further explore these recommendations, particularly the provision of a data service by the county as noted in recommendation 9."

On February 1, 2022 staff received a letter from the County of Simcoe Clerk's Department on behalf of the Service Delivery Task Force asking for feedback on the report.

At the February 10, 2022 Community Services Section of Coordinated Committee the Fire Chief provided a report requesting that if Council members had comments concerning the proposed efficiencies, service delivery models and recommendations outlined in the review, that they provide such comments to the Chief Administrative Officer.

# DISCUSSION

Based on the feedback from individual Council members, it is felt two of the ten recommendations found within the Pomax report warrant additional exploration.

Recommendation number nine supports the County providing data collection and analysis services due to challenges for smaller municipalities undertaking the same exercise. While conducting interviews with municipalities, Pomax received comments from several Chief Administrative Officers indicating that the County could assist as a data and information centre. This would ensure that the data required to make decisions is collected and what is collected is standardized across the County. One area identified is outcome information, similar to the data collected by other emergency services. With automation, training and building on data already collected for other purposes, this should be fairly easy to implement.

Recommendation number ten supports the creation of a committee comprised of municipalities and representatives of the County to further explore all of the recommendations, in particular the provision of a data service by the County as noted in recommendation nine. Some areas of interest include, sharing in the recruiting of volunteer Fire Fighters, Fire Prevention and Training. It was noted that a "...significant level of cooperation and sharing in Simcoe was identified..." as already occurring.

Although it was not considered as part of the review or a recommendation, some Council members feel the disproportionate escalation of firefighter wages and benefits, supported by the Arbitration system, is an issue that deserves attention and resources. It is acknowledged that this is beyond a local issue and should be addressed by the province as a priority as it impacts all fire services.

In discussing the recommendations with the Fire Chief, he is committed to reviewing all aspects of his administration and operations to identify areas to improve efficiencies and service delivery in the spirit outlined in the Promax Report.

Minister's Zoning Orders (MZOs) are being misused and overused by Ontario's provincial government in a way that damages the environment, threatens our safety, and saddles municipalities with ill-considered sprawl that will drag us down for decades to come. While there are very rare emergencies that warrant speeding up the approval process, the government has changed the law to let the Minister issue MZOs that would otherwise be unlawful – because they violate fundamental planning rules or even create floods and landslide risk.

We cannot wait and fight sprawl MZOs case-by-case, because there is no transparent MZO process: an MZO could be requested and issued arbitrarily by the Minister before our municipality and Council even hear about it. Council must be proactive in protecting our community from these dangerous Minister's Zoning Orders, by passing a motion which (1) tells developers in advance that you will not request or endorse any request for a MZO that does not meet strict and transparent criteria, (2) preemptively asks the province not to issue any MZO that fails to meet those criteria, and (3) asks the Ontario legislature to legally prohibit MZOs that do not meet those criteria.

The text of that motion would be as follows:

1. That the Township of Wilmot will not make a request for or indicate its approval of any Minister's Zoning Order applicable to land within the Township of Wilmot, excepting Orders:

a. which are limited to addressing an extraordinary and emergent circumstance that is a matter of provincial interest,

b. which are limited to measures which the Township of Wilmot could not otherwise bring into force in time to adequately address the relevant extraordinary and emergent circumstance,

c. which are consistent with the Official Plan, Provincial Policy Statement, 2020, and Growth Plan for the Greater Golden Horseshoe and s. s. 24, s. 2, s. 3 of the Planning Act,

d. which do not authorize urbanization outside of settlement area boundaries,
e. which do not authorize development that would destroy or displace a Provincially
Significant Wetland, Provincially Significant Woodland, Provincially Significant Valley
Lands, Provincially Significant Wildlife Habitat, Coastal Wetlands, Areas of Natural
and Scientific Interest or farmland,

f. which are framed geographically or in their wording so as to not to limit any power that a Conservation Authority would otherwise have, and

g. which are supported by the Minister's comprehensive, written, and publiclydisclosed reasons for determining that the above criteria have been met.

2. That the Township of Wilmot request the Government of Ontario, including the Minister of Municipal Affairs and Housing place an immediate and permanent moratorium on the issuance of Minister's Zoning Orders applicable to land within the Township of Wilmot, excepting Orders:

a. which are limited to addressing an extraordinary and emergent circumstance that is a matter of provincial interest,

b. which are limited to measures which the Township of Wilmot could not otherwise bring into force in time to adequately address the relevant extraordinary and emergent circumstance,

c. which are consistent with the Official Plan, Provincial Policy Statement, 2020, and Growth Plan for the Greater Golden Horseshoe and s. s. 24, s. 2, s. 3 of the Planning Act,

d. which do not authorize urbanization outside of settlement area boundaries,
e. which do not authorize development that would destroy or displace a Provincially
Significant Wetland, Provincially Significant Woodland, Provincially Significant Valley
Lands, Provincially Significant Wildlife Habitat, Coastal Wetlands, Areas of Natural
and Scientific Interest or farmland,

f. which are supported by the Minister's comprehensive, written, and publiclydisclosed reasons for determining that the above criteria have been met, and g. whose issuance is expressly requested through a lawfully adopted motion of the Township of Wilmot.

3. That the Township of Wilmot request the Government of Ontario and the Ontario Legislative Assembly amend the *Planning Act* to prohibit the issuance of Minister's Zoning Orders applicable to land within the boundaries of any municipality, excepting Orders:

a. which are limited to addressing an extraordinary and emergent circumstance that is a matter of provincial interest,

b. which are limited to measures which the municipality could not otherwise bring into force in time to adequately address the relevant extraordinary and emergent circumstance,

c. which are consistent with the Official Plan, Provincial Policy Statement, 2020, and Growth Plan for the Greater Golden Horseshoe and s. s. 24, s. 2, s. 3 of the Planning Act,

d. which do not authorize urbanization outside of settlement area boundaries,

e. which do not authorize development that would destroy or displace a Provincially Significant Wetland, Provincially Significant Woodland, Provincially Significant Valley Lands, Provincially Significant Wildlife Habitat, Coastal Wetlands, Areas of Natural and Scientific Interest or farmland,

f. which are framed geographically or in their wording so as to not to limit any power that a Conservation Authority would otherwise have

g. which are supported by the Minister's comprehensive, written, and publicly-

disclosed reasons for determining that the above criteria have been met, and

h. whose issuance is expressly requested through a lawfully adopted motion of

the municipal government(s) to whose territory the Order pertains.

# BY-LAW TO AUTHORIZE THE USE OF ALTERNATE VOTING METHODS AT MUNICIPAL ELECTIONS

**Whereas** section 42 (1) of the Municipal Elections Act, 1996, S.O. 1996, c.32, provides that a municipal council may pass a by-law authorizing an alternative voting method that does not require electors to attend a voting place in order to vote; and

**Whereas** section 42 (5) of the Municipal Elections Act, 1996, S.O. 1996, c.32, provides that when a By-law authorizing the use of an alternative voting method is in effect, section 43 (Advance Votes) and section 44 (Appointment of Voting Proxy) apply only if the By-law so specifies;

**And Whereas** the Council of the Township of Wilmot deems it appropriate to conduct the 2022 Municipal Election using internet and telephone voting methods;

**Now Therefore** the Council of the Corporation of the Township of Wilmot enacts as follows:

- 1. Internet and telephone alternative voting methods are authorized for the 2022 Municipal Election, including the advance voting period.
- 2. No proxy voting will be permitted for the 2022 Municipal Election conducted in accordance with this By-law.
- 3. The Clerk is authorized to sign any necessary agreements to allow for internet and telephone voting services during the 2022 Municipal Election.

That this By-law shall come into full force and effect upon final passing

# BY-LAW TO FURTHER AMEND BY-LAW NO. 83-38 OF THE TOWNSHIP OF WILMOT BEING A ZONING BY-LAW FOR THE SAID TOWNSHIP OF WILMOT.

WHEREAS The Corporation of the Township of Wilmot deems it desirable to further

amend By-law No. 83-38, being a Zoning By-law for the said Township of Wilmot.

# NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE

# TOWNSHIP OF WILMOT ENACTS AS FOLLOWS:

- Notwithstanding the provisions of By-law 83-38, as amended, on the lands described on Schedule "A" and illustrated on Schedule "B" attached to and forming part of this By-law, the following regulations shall apply:
  - a) dwelling units shall be permitted with or without the presence of a permitted commercial use on the property;
- Notwithstanding the provisions of By-law 83-38, as amended, for the lands described on Schedule "A" and illustrated on Schedule "B" attached to and forming part of this By-law, the following shall be added as Section 22.301:

Notwithstanding any other provisions of this By-law, the lands described as Part of Lots 14 and 15, Plan 627 and identified on the map forming Part 2b of Schedule 'A', shall be subject to the following regulations:

- a) dwelling units shall be permitted with or without the presence of a permitted commercial use on the property
- 3. Notwithstanding the provisions of By-law 83-38, as amended, the map forming Part
  2b of Schedule 'A' to By-law 83-38 shall be amended as necessary to identify Section
  22.301 on the lands described on Schedule 'A' and illustrated on Schedule 'B' attached to and forming part of this By-law.
- Except as amended by the preceding regulations, the lands described on Schedule
  "A" attached to and forming part of this by-law and shown on Schedule "B" attached to and forming part of this by-law, shall be subject to all other applicable regulations as set down in By-law No. 83-38, as amended.
- This by-law shall come into effect on the final passing thereof by the Council of The Corporation of the Township of Wilmot subject to compliance with the provisions of The Planning Act, R.S.O., 1990 and amendments thereto.

READ a first and second time on the  $\mathbf{28^{th}}$  day of March, 2022.

READ a third time and finally passed in Open Council on the  $28^{th}$  day of March, 2022.


